1. Introduction

This form contains a series of questions that need to be answered. Complete all of the fields in the questionnaire. The completed document is a Conformance Statement for your Organization as to how you comply with the Open Trusted Technology Provider Standard (O-TTPS), Version 1.0. Your completed form must be submitted to the Accreditation Authority as part of your application for accreditation. Please note that all information in this Conformance Statement will appear on the public O-TTPS Accreditation Register.
